

# Privacy Policy

Swift Scaffolding Ltd (“Swift Scaffolding”) operates [www.swift-scaffolding.com](http://www.swift-scaffolding.com) and may operate other websites. It is Swift Scaffolding’s policy to respect your privacy regarding any information we may collect while operating our websites.

## Website Visitors

Like most website operators, Swift Scaffolding collects non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. Swift Scaffolding’s purpose in collecting non-personally identifying information is to better understand how Swift Scaffolding’s visitors use its website. From time to time, Swift Scaffolding may release non-personally-identifying information in the aggregate, e.g., by publishing a report on trends in the usage of its website.

Swift Scaffolding also collects potentially personally-identifying information like Internet Protocol (IP) addresses for logged in users and for users leaving comments on [www.swift-scaffolding.com](http://www.swift-scaffolding.com) blogs/sites. Swift Scaffolding only discloses logged in user and commenter IP addresses under the same circumstances that it uses and discloses personally-identifying information as described below, except that commenter IP addresses and email addresses are visible and disclosed to the administrators of the blog/site where the comment was left.

## Gathering of Personally-Identifying Information

Certain visitors to Swift Scaffolding’s websites choose to interact with Swift Scaffolding in ways that require Swift Scaffolding to gather personally-identifying information. The amount and type of information that Swift Scaffolding gathers depends on the nature of the interaction. For example, we ask visitors who sign up at [www.swift-scaffolding.com](http://www.swift-scaffolding.com) to provide a username and email address. Those who engage in transactions with Swift Scaffolding are asked to provide additional information, including as necessary the personal and financial information required to process those transactions. In each case, Swift Scaffolding collects such information only insofar as is necessary or appropriate to fulfil the purpose of the visitor’s interaction with Swift Scaffolding. Swift Scaffolding does not disclose personally-identifying information other than as described below. And visitors can always refuse to supply personally-identifying information, with the caveat that it may prevent them from engaging in certain website-related activities.

## Aggregated Statistics

Swift Scaffolding may collect statistics about the behaviour of visitors to its websites. Swift Scaffolding may display this information publicly or provide it to others. However, Swift Scaffolding does not disclose personally-identifying information other than as described below.

## Protection of Certain Personally-Identifying Information

Swift Scaffolding discloses potentially personally-identifying and personally-identifying information only to those of its employees, contractors and affiliated organisations that (i) need to know that information in order to process it on Swift Scaffolding’s behalf or to provide services available at Swift Scaffolding’s websites, and (ii) that have agreed not to disclose it to others. Some of those employees, contractors and affiliated organisations may be located outside of your home country; by using Swift Scaffolding’s

websites, you consent to the transfer of such information to them. Swift Scaffolding will not rent or sell potentially personally-identifying and personally-identifying information to anyone. Other than to its employees, contractors and affiliated organisations, as described above, Swift Scaffolding discloses potentially personally-identifying and personally-identifying information only in response to a court order or other legal request, or when Swift Scaffolding believes in good faith that disclosure is reasonably necessary to protect the property or rights of Swift Scaffolding, third parties or the public at large. If you are a registered user of an Swift Scaffolding website and have supplied your email address, Swift Scaffolding may occasionally send you an email to tell you about new features, solicit your feedback, or just keep you up to date with what's going on with Swift Scaffolding and our products. If you send us a request (for example via email or via one of our feedback mechanisms), we reserve the right to publish it in order to help us clarify or respond to your request or to help us support other users. Swift Scaffolding takes all measures reasonably necessary to protect against the unauthorised access, use, alteration or destruction of potentially personally-identifying and personally-identifying information.

## Cookies

A cookie is a string of information that a website stores on a visitor's computer, and that the visitor's browser provides to the website each time the visitor returns. Swift Scaffolding uses cookies to help Swift Scaffolding identify and track visitors, their usage of Swift Scaffolding website, and their website access preferences. Swift Scaffolding visitors who do not wish to have cookies placed on their computers should set their browsers to refuse cookies before using Swift Scaffolding's websites, with the drawback that certain features of Swift Scaffolding's websites may not function properly without the aid of cookies.

## Business Transfers

If Swift Scaffolding, or substantially all of its assets, were acquired, or in the unlikely event that Swift Scaffolding goes out of business or enters bankruptcy, user information would be one of the assets that is transferred or acquired by a third party. You acknowledge that such transfers may occur, and that any acquirer of Swift Scaffolding may continue to use your personal information as set forth in this policy.

## Ads

Ads appearing on any of our websites may be delivered to users by advertising partners, who may set cookies. These cookies allow the ad server to recognise your computer each time they send you an online advertisement to compile information about you or others who use your computer. This information allows ad networks to, among other things, deliver targeted advertisements that they believe will be of most interest to you. This Privacy Policy covers the use of cookies by Swift Scaffolding and does not cover the use of cookies by any advertisers.
